

Music Center of the Northwest is a non-profit community music school located in North Seattle. We believe in the transformative power of music in the lives of people and our community. (Continued on Sch O)

Music Center provided music lessons to 294 students in 2016-17. Of that total, 52 received tuition assistance in order to participate. Lesson instruction accounted for 4219 hours of instruction. One-to-one instruction with a certified teacher was the focus of the program. Students had the opportunity to perform throughout the year at student recitals.

4b (Code:) (Expenses \$ **103,418.** including grants of \$) (Revenue \$ **63,809.**)

The Music Together program had 504 enrollments in 2016-17. Students ranged in age from 6 months to 7 years old, and attended classes with a caregiver. The classes focused on music and movement, teaching basic music skills. There are no performances.

New Perspectives, an adult program for group instruction, had 328 enrollments in 2016-17. Additionally, three other adult ensembles that rehearsed at Music Center had a total of more than 150 participants. Participants in performing ensembles presented concerts throughout the year at both Music Center and in the community.
